FORMAT/SCHEDULE FOR SELECTION TRIALS:

The qualified teams which have complied with the conditions related to the participation for the 16th World Bridge Games and thereby eligible for selection trials are as under:

FINALS:

12TH JUNE: FORMIDABLES VS WINNER OF (DSM vs SAMADHAN) (4 SEGMENTS X 15 BOARDS)
13TH JUNE: FORMIDABLES VS WINNER OF (DSM vs SAMADHAN) (4 SEGMENTSX 15 BOARDS)

In case of a Tie, Tie Break procedures as given in Supplemental Conditions of Contest to be followed.

All members of the above eligible teams have to comply with the guidelines given in the General/Supplemental Conditions of Contest before obtaining final clearance certificate from the federation for national representation purpose.

- IF 3 TEAMS THEN QUALIFCATION LEAGUE (based of result of DSM in Open event):

14TH JUNE: 3 TEAMS WILL PLAY 14 BOARDS X 4 MATCHES (TURNER MOVEMENT) - **56 BOARDS.** EACH SEGMENT WILL HAVE 7 BOARDS AGAINST EACH TEAM, SO 14 BOARDS PER SEGMENT. Imps converted to VP as per 20-0 WBF Decimal Scale.

15TH JUNE: 2 MORE SEGMENTS WITH TURNER MOVEMENT CONTINUES – **28 BOARDS**

(TOP 2 TEAMS ADVANCE TO FINALS)

FINALS:

MIX TEAMS/WOMEN TEAMS:

As the Federation has received only 1 entry in the both disciplines (Mix and Women) respectively within the given stipulated deadline, entries for any additional teams were closed thereby and the matter had been referred to the Credentials Committee. The members of the credentials committee have unanimously decided to nominate the team which had registered within the stipulated deadline as the Indian Team for the Mix Team and Ladies Team disciplines respectively for the upcoming 16th World Bridge Games subject to compliance with the guidelines given in the General/Supplemental Conditions of Contest for national representation purpose.

The Federation looks forward for more participation and competition in the above disciplines in the 2017 World Bridge Team Championships event with the growing ladies bridge fraternity all over India.
