I am participating in the selection camp for INDIAN Open / Women/ Mixed / Senior / (delete as necessary)

- 1. I agree and commit myself to participate in the Indian Team selection camp in the category mentioned above to be held at Shiv Nadar University Noida From ------ to ------ March -2023.
- 2. I am aware that the event is governed by the Laws of Bridge, the Conditions of Contest, the Disciplinary Code, the NADA & WADA rules, and Regulations of the Bridge Federation of India (BFI). I undertake to comply with such rules, all of which are fully known to me.
- 3. I agree to be submitted to such rules, regulations, and procedures to the jurisdiction of the bodies and persons that are in charge of applying them.
- 4. I understand that the reimbursements will be made as per the SAI rules and regulations, and I will have no further claims on BFI.
- 5. I undertake to conduct myself, at all times, in true spirit of sportsmanship, and ensure that my actions, behaviour or speech does not tarnish image of the BFI, my country, the Championship event or the host country.
- 6. I accept to abstain from political actions, statements or comments during the event. BFI will, without limitation, not be responsible for any political, financial or other sanctions that local or national authorities may impose on me.
- 7. I accept that BFI has the final authority to exclude me from the event, in case of non-compliance with this commitment (including any applicable BFI rules and regulations) or in case of misconduct, the meaning of which shall take into account local customs and traditions.
- 8. I confirm that I have not received any information, including without limitation, advice by a physician or another person that my health might be negatively affected or my level of fitness not be sufficient to participate in the Championship event. I also certify that I am in good health and my physical and mental fitness will not in any way affect my participation in the selection trials, and if selected, representing India at international events.
- 9. I agree that I will be responsible for any damage that I may cause to persons or property and that I will be liable for indemnifying such damage. I accept that BFI or any of its officials, will not be liable under any circumstances in connection with any damage that I may cause during the event.
- 10. I accept and agree not to bring into the competition area or to possess or use in the competition area any electronic devices (for example smart phones, smart watches, wearable wireless devices, pocket computers etc). I accept and agree to be inspected in order to ensure compliance with this clause.

- 11. I accept and agree not to smoke or to consume alcoholic beverages at the competition venue,
- 12. I accept to be subject to the anti-doping rules of WADA -NADA BFI. In particular I accept to submit to doping control by or at the request of BFI and I accept consequences and sanctions as well as the jurisdiction of as provided for in the anti-doping rules of BFI. I also commit to obtain a TUE certificate from NADA in case I am under treatment for any ailment for which the prescription drug contains one or more banned substance as per WADA list of banned substances.
- 13. I agree to be photographed, filmed, identified and otherwise recorded during the event, both during and outside the competitions. I accept that such photos, films, footage and other recordings may publicized and broadcast worldwide by any means (TV, internet etc.) and are used by BFI and the host for non-commercial promotion purposes at no cost to BFI or the host.
- 14. I fully understand and agree that my participating partner / team shall have Bridge players of Indian Nationality who can carry Indian flag at international competitions and comply with the norms laid down by the Ministry of Sports and Youth affairs as well as guidelines of Bridge Federation of India for selection criteria.
- 15. Should I be selected to represent India, I agree that I will attend all subsequent coaching camps/ practice sessions as stipulated by the BFI/ BFI appointed coach without fail and shall abide by the directives of the coach completely. I also commit to play only with my partner that I am selected with for all subsequent events whether live or online, till completion of the Asian Games 2023 when instructed to do so. I also commit to follow the instructions of my coach / NPC in terms of seating and play both during practice as well as actual competition.
- 16. I shall fully comply with the social media norms as per the BFI guidelines mentioned below.
 - BFI welcomes all accredited participants to post comments on social media platforms or websites and tweet during any BFI recognized national tournaments with the aims of sharing personal experiences, communicating with families and friends, in the form of a personal posting, blog or tweet.
 - However, any such postings, blogs or tweets must be in a first-person, diary-type format and should not be in the role of a journalist i.e. they must not report on competition or comment on the activities of other participants or accredited persons base on any doubt and/or suspicion that may cause any misunderstanding and/or confusion or disclose any information which is confidential or private in relation to any other person or organization.

Postings, blogs and tweets must not contain any commercial, political, or religious views and must not disparage or defame any participants, accredited persons, BFI officials or any country or region participating in the competitions.

Postings, blogs and tweets should at all times conform to the bridge game spirit and fundamental principles of Olympics which can be dignified and in good taste, and not contain vulgar or obscene words or images.
