Sub: Pronouncement of Disciplinary Sanction for the Misconduct observed at 8th World Youth Transnational Bridge Championships held at Wroclaw, Poland from 13-18th July

The BFI Executive Committee vide its executive meeting held on 17th September 2024 appraised the recommendations of the BFI Disciplinary Committee with respect to your case and has unanimously agreed to pronounce the following disciplinary sanction as under:

- Disqualify Mr. Soham Sarkar from participating in any BFI affiliated bridge event in the capacity as a “bonafide player” held in India from 1st October 2024 to 30th September 2025
- Disqualify Mr. Soham Sarkar from representing India or participating in any selection event for Open/Juniors/Mixed categories for 3 years in the capacity as a “bonafide player” starting from 1st October 2024 till 30th September 2027 subject to evaluation of your code of conduct.

You have a right to appeal on the above judgement to the Disciplinary Committee latest by 15th November, 2024 after which the BFI Executive Committee will appraise the case and deliver its final judgement on receiving the recommendation from Disciplinary Committee.

Mr. Soham Sarkar Player ID 707989 will be deactivated from 15th October 2024 from Bridge Federation of India Masterpoint database subject to completion of the ban period or any announcement of reduced punishment whichever is earlier with a written communication to all member state associations to take notice of the same.
